2 CSR 30-9.020 (9) (B) 4. Animal shelters, contract kennels, pounds or dog pounds may use distinctive cage cards. Cage cards, if used, must be sequentially numbered, used in sequential order and placed in an area which will prevent animals, water or cleaning solutions from contacting them or damaging the cards.

8/12/2013 - Many of the dogs were either improperly identified or not identified at all. The licensee will need to identify all animals with a sequential numbering system.
